

# **Event Waiver**

On my own behalf and on the behalf of my heirs, successors and assigns, I hereby forever release and discharge and agree to indemnify New England Surf ("NES") FC Boston Bolts ("FCBB"), and TapIn Sports ("TS") (each of their Officers, Directors, Employees, Agents, Shareholders, Members, Partners, Representatives, and all owners and Operators of all sites at which "NES" "FCBB" and "TS" conduct try-outs, clinics, tournaments, events, practices or games, and their respective affiliates, and all the representatives (collectively the "released parties") from any and all liabilities, claims, costs, demands or causes of action, whether known or unknown ("claims") that I may now or hereafter have for injuries or damages arising out of my participation in "NES," "FCBB" and "TS" and any related activity including without limitation clinics, try-outs, games, training sessions, and Tournaments.

I understand and acknowledge that dangers of personal injury are inherent in participating in soccer clinics, try-outs, tournaments, events, games, or training sessions, and I expressly and voluntarily assume all risk of death or personal injury sustained in the clinics, try-outs, tournaments, events, games and training sessions, including the risk of passive or active negligence of the released parties, or hidden, latent or obvious defects in any facilities or equipment used. I acknowledge the possibility that my successors or I may not fully know the number or magnitude of all claims and agree that this release is a full and final release of all claims. This release is intended to be binding on my heirs and assigns. This release is being signed in consideration of the opportunity to play in "NES", FCBB" and "TS" events. It is an agreement made under seal and is governed by law.

I also understand and specifically acknowledge that participation in the activities outlined include possible exposure to an illness from infectious diseases including but not limited to MRSA, influenza, and COVID-19. While particular rules and personal discipline may reduce this risk, the risk of exposure still will exist.

## **Talent Release**
